



### Scope

The *International Journal of Taiwan Studies (IJTS)*, cosponsored by Academia Sinica and the European Association of Taiwan Studies, is a principal outlet for the dissemination of cutting-edge research on Taiwan. Its editorial office is supported by Taiwan's Ministry of Foreign Affairs and is hosted by the Department of International Politics, Aberystwyth University. *IJTS* offers a unique platform for theoretical debates and empirical analyses that move away from narrow disciplinary focus by creating a meeting space for international scholars across the field of Taiwan Studies, including social sciences, arts and humanities, and subjects that are interdisciplinary in nature. *IJTS* welcomes submissions that are localised in focus (for example, analysis of a specific historical or current event) and that are more global in their outlook (for example, forging links between Taiwan and a wider international, cultural or intellectual context). Researchers are encouraged to position Taiwan and Taiwan-related issues in a comparative framework or different global, regional and local—some may term it 'glocal'—contexts and processes. *IJTS* publishes internationally peer-reviewed research articles, special thematic issues, book reviews and review essays of works published in non-English languages.

### Online Submission

*IJTS* uses online submission only. Authors should submit their manuscript online via the Editorial Manager (EM) online submission system at: [editorialmanager.com/ijtsbrill](http://editorialmanager.com/ijtsbrill). First-time users of EM need to register first. Go to the website and click on the "Register Now" link in the login menu. Enter the information requested.

When you register, select e-mail as your preferred method of contact. Upon successful registration, you will receive an e-mail message containing your Username and Password. If you should forget your Username and Password, click on the 'Send Username/Password' link in the login section, and enter your first name, last name and email address exactly as you had entered it when you registered. Your access codes will then be e-mailed to you.

Prior to submission, authors are encouraged to read the 'Instructions for Authors'. When submitting via the website, you will be guided stepwise through the creation and uploading of the various files.

A revised document is uploaded the same way as the initial submission. The system automatically generates an electronic (PDF) proof, which is then used for reviewing purposes. All correspondence, including the editor's request for revision and final decision, is sent by e-mail.



## *Instructions for Authors*

---

### *Double-blinded Peer Review*

*IJTS* uses a double-blind peer review system, which means that manuscript author(s) do not know who the reviewers are, and that reviewers do not know the names of the author(s). When you submit your article, you should submit a separate title page which includes the full title of the manuscript plus the names and complete contact details of all authors. This page will not be accessible to the referees. All other files (manuscript, figures, tables, etc.) should not contain any information concerning author names, institutions, etc. The names of these files and the document properties should also be anonymized.

### *File Format*

Please upload source files such as .doc, and not .pdf files.

## **Submission Requirements**

The Executive Editor Board is responsible for the selection and acceptance of articles, but responsibility for opinions expressed in them rests with the authors.

### *Language*

Manuscripts should be written in English. Spelling (British) should be consistent throughout.

### ***Manuscript Length***

Manuscripts submitted for publication in the journal must comply with the following: articles should be between 6,000 to 10,000 English words; review essays, between 3,000 to 5,000 words and book reviews, between 800 to 1,200 words.

## **Manuscript Structure**

Manuscripts must be double-spaced with wide margins.

The manuscript should be submitted as two files. The title page should contain the title, followed by the author(s)' name(s), title, affiliation and e-mail address(es). This should be followed by a brief biographical note and research interests, recent publications.

The second file should contain the manuscript, starting with the title, abstract, keywords, text and references.

#### **Abstract and Keywords**

An abstract of 100–150 words should accompany papers, as well as between three to six keywords.

#### **Dates**

17 June 2017, 100 B.C.E., 600 C.E., 1980s (not 1980's or '80s), etc.

#### **Quotations**

Use single quotation marks (') for a simple quotation. For a quotation within a quotation, use double quotation marks ("). A comma or a period (full stop) should be placed outside quotation marks in all situations. For texts longer than 3 lines, use a block quotation, indented half an inch from the left margin. In this case, no quotation marks are necessary at the beginning and end of the quotation.

#### **Romanization and Chinese Characters**

1. Use *pinyin* without tone marks to denote names of Chinese people (e.g. Xi Jinping), locations (e.g. Hengchun), and specialized terms (*jiankang xieshi*). Non-*pinyin* spellings (e.g. Wade-Giles) should only be used in cases where a certain name or term has been widely adopted (e.g. Chiang Kai-shek), or in quotations or titles.
2. Any Chinese writing should use traditional characters. Chinese terms and titles of Chinese texts, on their first appearance in the text, should be written in the following format: English translation (Chinese characters, *pinyin*). For example, Democratic Progressive Party or DPP (民進黨, *min jin dang*). Subsequent appearances should be either in English or *pinyin* and should be consistent throughout.

#### **Footnotes**

Notes should be kept to a minimum and numbered consecutively throughout the article. Notes should be included as footnotes, and *not* as endnotes.

#### **References in the Text**

All source references are to be identified at the appropriate point in the text by the last name of the author, year of publication and pagination where needed. Identify subsequent citations of the same source in the same way as the first. Examples follow:

- If author's name is in the text, follow it with year in parentheses, e.g., Zhang (1999).
- If author's name is not in the text, insert, in parentheses, the last name and year, e.g., (Smith, 2016).

- Pagination follows year of publication after a colon, e.g., Brown (1985: 72).
- Give both last names for two authors. Give all last names on first citation in text for more than two authors; thereafter use “et al.” in the text. When two authors have the same last names, use identifying initials in the text.
- Separate series of references with semi-colons and enclose them within a single pair of parentheses, e.g., (Edwards, 1981; Lee et al., 1983).

### **Reference List**

List all items alphabetically by author and, within author, by year of publication, at the end of the manuscript, entitled “References”.

If there is more than one reference to the same author and year, distinguish them by the letters a, b, c, etc. after the year (2013a). The titles of books and journals should be in italics. Examples follow:

### **Figures**

All charts, maps, images and illustrations should be called “figures” and numbered consecutively; the number and title should be placed above the figure. Initial capitals should be used.

All figures and tables must be cited consecutively in the text.

Figures should be submitted as separate source files in .eps, .tif, or .jpg format, in a size suitable for the typesetting area of the journal. The resolution of these files should be at least 300 dpi for half-tone figures, and 600 dpi for line drawings. Number the files, and indicate in the manuscript where they are to appear (Fig. 1 here). All figures should be in black and white.

The text in a figure must be legible, and should not be smaller than corps 7. The size of this lettering for any text in a figure should be the same for all figures in the manuscript.

Authors are responsible for clearing copyright of using figures and tables in the articles submitted.



## Book Reviews

Reviews should situate the book(s) in a wider disciplinary context and limit length to 800–1200 words, typed with double-spacing. Reviews should be sent to Professor Gary Rawnsley ([gdr1@aber.ac.uk](mailto:gdr1@aber.ac.uk)).

Please follow the format below in preparing your review:

*Flush left*

Place of Publication, Publisher

pp., illus.;

*At the end of the review, flush left*

## Publication

### *Proofs*

Upon acceptance, a PDF of the article proofs will be sent to the author by e-mail to check carefully for factual and typographic errors. Authors are responsible for checking these proofs and are strongly urged to make use of the Comment & Markup toolbar to note their corrections directly on the proofs. At this stage in the production process only minor corrections are allowed. Alterations to the original manuscript at this stage will result in considerable delay in publication and, therefore, are not accepted unless charged to the author. Proofs should be returned to the Editor.

### *E-Offprints*

A PDF file of the article will be supplied free of charge by the publisher to each author. Brill is a RoMEO green publisher.

Authors are allowed to post their submitted (pre-peer-review) version of the article at any time. This is the author's own version that had not yet been peer-reviewed, or had any value added to it by Brill (such as formatting or copy editing). Authors may post the accepted (peer-reviewed) version of their article 24 months after publication. This is the version accepted for publication, which contains all revisions made after peer review and copy editing, but has not yet been typeset in the publisher's lay-out. The publisher's lay-out must not be used in any repository or on any website.



## Consent to Publish

### *Transfer of Copyright*

By submitting a manuscript, the author agrees that the copyright for the article is transferred to the publisher if and when the article is accepted for publication. For that purpose the author needs to sign the **Consent to Publish** which will be sent with the first proofs of the manuscript.

### *Open Access*

Should the author wish to publish the article in Open Access he/she can choose the Brill Open option.

This allows for non-exclusive Open Access publication under a Creative Commons license in exchange for an Article Publication Charge (APC), upon signing a special Brill Open Consent to Publish Form.
